

Passport and VISA Requirements

Getting around

Transportation from Lisbon International Airport Lisbon also known as Lisbon Portela Airport is the main international gateway to Portugal. Lisbon Airport is located 7km north of the capital. This strategic location makes it easy to get to your hotel.

In Lisbon, there is a bus network, an underground metro with four lines and in the older parts of the city, the emblematic trams. The public transport link between the two venues is the [Linha de Cascais](#) tram (EDP HQ –*Cais do Sodré* stop - | Congress Centre –between *Alcantara-Mar* and *Belém* stop-).



The buses [714 Outurela](#) and [732 Caselas](#), which can be taken respectively at *Rua de São Paulo/Bica* and *Santos*, stop directly in front of the Congress Center (*R. Junqueira*).

A taxi ride between the venues takes about 8-9 minutes. Taxis in Portugal are either beige or black and green and are legally required to have a taximeter on board.
